### ORDER

As per Government order read as 1st paper above, sanction had been accorded for the release of 1st tranche of 1st installment of Central share and its matching State share for the implementation of NRLM for the year 2024-25. As per letters read as 2nd to 4th paper above, the Ministry of Rural Development has sanctioned an amount of ₹44,68,01,000/- (General-₹39,34,08,000/-, SCP-₹4,61,10,000/- and TSP-₹72,83,000/-) as the 2nd tranche of 1st installment of the Central share for the implementation of NRLM for the year 2024-25. Being the implementing agency of NRLM in the state, the Executive Director, Kudumbashree, as per letter read as 5th paper above, has informed that the matching State share of the Central release is ₹29,78,67,333/- (General-₹26,22,72,000/- SCP - ₹3,07,40,000/- and TSP- ₹48,55,333/-), which comes to a total amount of ₹74,46,68,333/-. The Executive Director, Kudumbashree has also reported that as per the budget document, there is a shortage of ₹4,53,81,000/- in General component of

Central Share under the head of account 2501-06-198-48-03 and requested to release the 2nd tranche of 1st installment of the Central share and corresponding State share for the implementation of NRLM for the year 2024-25.

2. Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹69,92,87,333/- (Rupees Sixty Nine Crore Ninty Two Lakh Eighty Seven Thousand Three Hundred and Thirty Three Only) to Kudumbashree as the 2nd tranche of 1st installment of Central share and its matching State share for the implementation of NRLM for the year 2024-25, from current year's budget provision, as detailed below:
