### ORDER

As per the guidelines of UIDF , "the State Governments are expected to collate and prioritize the list of eligible projects to be funded under a particular year/tranche of UIDF with the approval of the respective State level committee ie:-State level Technical Committee/High power steering committee. States may designate any of the existing committees or constitute a Committee for scrutiny and prioritization of eligible proposals under UIDF".

2. As per G.O read as 1<sup>st</sup> and 2<sup>nd</sup> paper above, Government have constituted a State Level Technical Committee (SLTC) and a State Level High Powered Steering Committee (SHPSC) for AMRUT.

3. As per the letter read as 3<sup>rd</sup> paper above, Mission Director AMRUT has reported that the projects under Urban Infrastructure Development Fund (UIDF) are now aligned with the AMRUT Mission and proposed that the State Level Technical Committee (SLTC) and State Level High Powered Steering Committee (SHPSC) of AMRUT 2.0 may be designated for the scrutiny, prioritization, periodical review, and administrative approval of UIDF projects.

4. As per the minutes read as 4<sup>th</sup> paper above, the meeting chaired by

Chief Secretary has decided to constitute an apex committee, designating SLTC and SHPSC of AMRUT 2.0, for the scrutiny, prioritization, periodical review, and administrative approval of UIDF projects

Government have examined the matter in detail and are pleased to designate State Level Technical Committee (SLTC) and State Level High Powered Steering Committee (SHPSC) of AMRUT 2.0 as State Level Committees for the scrutiny, prioritization, periodical review, and administrative approval of projects under Urban Infrastructure Development Fund (UIDF) Scheme.
