ORDER

The Chief Engineer, KSRRDA as per letter read as 1st paper above has reported that M/s. O.P Pathrose and Company had undertaken the PMGSY Work having Package No.KR 02-59 Rubber park Alinchuvadu Tank city - Meprathupady Mankuzhi road in Ernakulam and executed agreement on 12.04.2022. As there was no progress in work, several notices were issued to complete the work in time. Against this the contractor filed WP(C) No. 29618/2024 with a request to stop further actions against him and as per the Interim Order dated 22.08.2024, the Court has directed the Chief Engineer, KSRRDA to take a decision on Ext.P8 representation of the Petitioner. Accordingly the Chief Engineer heard the petitioner and decided to refer the matter to the Standing Empowered Committee.

2) Also as per the judgement 2nd cited, the Hon'ble High Court has directed the Standing Empowered Committee to take a decision in the matter, after affording an opportunity of hearing to all concerned and to hold all coercive proceedings against the petitioners until the final decision.

3) Government have examined the matter in detail and are pleased

to constitute a Standing Empowered Committee (SEC), for redressal of the above dispute, with the following composition:

- i) Special Secretary, LSGD - Chairperson
- ii) Chief Engineer, KSRRDA - Official Member
- iii) Sri. R. Murukeshan, Chief Engineer (Rtd.), PWD – Non official Member

4) The Chief Engineer, KSRRDA is directed to take necessary steps to present the details of the case before the Standing Empowered Committee for settling the dispute.
