- 2. Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for the above 7 reworked estimates of PMGSY works viz, package Nos. KR 07-09, KR 11-83, KR 03-27B, KR 01-89, KR 01-78, KR 02-51, KR 02-64 for a total revised Administrative Sanction amount of ₹3311.23 Lakh against the original amount of ₹3016.02 Lakh with an increase of ₹295.21 Lakh subject to the following conditions and availability of funds:-
- a) The TS authority shall review the retaining wall/drainage/paneled concrete provisions provided for the work KR 02-51 after thorough verification as per actual site condition before issuing technical sanction considering necessity, economy and safety.
- b) The retaining wall proposed shall be as per the Circular No.87/2016/ Finance (Insp-tech) dated 18-11-2016 & Circular No.64/2021/Fin dated 05-08-2021 considering economy and stability.
 - c) The TS authority shall ensure that the additional provision sought

is used for the intended purpose only and shall not be diverted.

d) Ensure that the Government of India fund available, as per the PMGSY guidelines, shall be fully utilized in all these 7 works.
