Government as per GO read as 1 st paper above has approved the Rebuild Kerala Development Programme (RKDP) to promote policy and institutional reforms in order to enable long-term resilience to climate change effects and disasters. It is financed through a Program for Results (PforR) designed with the World Bank to achieve results organized in ten indicators (DLIs) . In addition to the mobilization of own resources by the GoK, RKDP is co-financed by IBRD, AIIB and AFD.

The Government of Kerala has secured external funding of Euro 100 million from the Agence Française de Développment (AFD) for the Resilient Kerala Program under the Rebuild Kerala Initiative. Additionally, a technical assistance program worth Euro 5,0,00,000 has been attached to enhance institutional partnerships between French and Kerala Institutions, aiming to bolster territorial resilience.

A tripartite Memorandum of understanding has been signed among the Government of Kerala, The Center for Studies and Expertise on Risks, the Environment, Mobility and Planning -CEREMA (technical partner) and L'agence Francaise De Development -AFD (Agency) for this technical assistance program. The MOU outlines in-kind technical assistance through classroom or online training on integrating risk information into urban planning, followed by a field visit to France.
