ORDER

As per letter read as 1st paper above, Sri. Reju K. Paul, contractor of the road work PMGSY-III-2021-22 (Batch-1) Package No. KR01 83, had filed an appeal before the Standing Empowered Committee (SEC). Accordingly, the Chief Engineer, KSRRDA, as per letter read as 2nd paper above, has reported that the PMGSY Work having Package No.KR01 83 Vedaraplave School Jn-Panayil Marthoma Palli Road, Bharanikavu Block, Alappuzha was awarded to the contractor Sri.Reju K. Paul and the agreement was signed on 13.04.2022. As there is slow progress in work, several notices were issued to complete the work in time. Later the contractor was heard in person by the Chief Engineer. As the explanation for delay was not acceptable, it was decided to terminate with risk and cost of the contractor. The Chief Engineer, KSRRDA has also reported that the Petitioner has selected Sri. R. Murukeshan, Chief Engineer (Rtd.), PWD as the Non-official Member for the Standing Empowered Committee and the risk and cost termination in the revenue recovery portal can be initiated after the Standing Empowered Committee decision.

to constitute a Standing Empowered Committee, for the redressal of the dispute, with the following composition:

- i) Special Secretary, LSG (DD) Department - Chairperson
- ii) Chief Engineer, KSRRDA - Official Member
- iii) Sri. R. Murukeshan, Chief Engineer (Rtd.), PWD – Non-official Member

3) The Chief Engineer, KSRRDA is directed to take necessary steps to present the details of the case before the Standing Empowered Committee for settling the dispute.
