## **ORDER**

Department of Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India have released SBRAP Plus and RCB(Reducing Compliance Burden) Plus 2024, consisting of additional reforms that have to be implemented as part of SBRAP 2024. One of the SBRAP Plus reform recommendations for the Local Self Government Department in Self certification and Third-party Ecosystem area is that "States/ UTs should ensure the creation of a task force to identify sectors and their respective necessary approvals/ compliances suitable for transitioning to self-certification for low risk inspections and to third party certification for medium risk inspections. Vide letter read 3rd paper above, Principal Director has requested to constitute a task force for the purpose

Duties and Responsibilities of the committee are as follows:

- 1. The committee shall review the existing approval process and inspections as part of issuing Building Rules and Licenses in Local self Government Institutions. It has to examine the aspect of Ease of Doing business in all the inspections procedures.
- 2. Review existing practices & procedures of inspections and to improve transparency and objectivity of inspections.
- 3. Review that inspections are conducted in a time bound manner.
- 4. Review of inspections scheduled and conducted by the Local Self Government Institutions

for various approvals and certifications and to analyse the efficiency of service delivery.

- 5. To identify inspections, its parameters and compliances as applicable under the approval where by low risk inspections/compliances can be transitioned into self certification and medium risk inspections/compliances to third party certifications to streamline government oversight and enhances compliance efficiency.
- 6. Review the promptness in issuing permits/licenses and pendency in the permits/licenses.
- 7. Review the pendency in Single Window Clearance System/ K SWIFT Portal/K Smart application.
