### ORDER

As per the GO read as 1<sup>st</sup> paper above, Government have accorded sanction to the Secretaries of the local bodies concerned to pay the compensation awarded by the Justice (Rtd) Sirijagan Committee to the claimants in the 41<sup>st</sup> report of the Committee.

As per letter read as 2<sup>nd</sup> paper above, the Principal Director, Local Self Government has reported that the Kunnothuparamba Grama Panchayat informed that as per report dated 19.02.2021 of Justice (Rtd) Siri Jagan Committee, the name of the claimant correspondence to the Claim No. 650/2020 is entered as Master Adwait, S/o Savitha instead of Master Sreyas, S/o Savitha and hence he has requested to issue an order clarifying the defect. It is also informed that the Joint Director, Kannur has requested to waive the penal interest for the period till the issuance of the modified order.

On 21.08.2024, Justice (Rtd) Siri Jagan Committee has reported that the name of the claimant mentioned against the Serial No 7 - Claim No. 650/2020 is wrongly entered as Master Adwait instead of Master Sreyas.

Government have examined the matter in detail and the name of the

Claimant entered against the Serial No 7 - Claim No. 650/2020 - Master Adwait, S/o Savitha - in the GO read as 1<sup>st</sup> paper above is corrected and read as Master Sreyas, S/o Savitha. Also penal interest for the period from 12/08/2024 is waived off. The Government order said above stands modified to this extent only.
