ORDER

As per G.O read as 1st paper above, , Government have designated the State Level Technical Committee (SLTC) and State Level High Powered Steering Committee (SHPSC) of AMRUT 2.0 ,as the State Level Committees for the scrutiny, prioritization, periodical review, and administrative approval of projects under Urban Infrastructure Development Fund (UIDF) Scheme.

Based on the recommendation of SLTC, as per the minutes read as 2nd paper above, 10th SHPSC of AMRUT 2.0 has decided to designate the Principal Directorate of LSGD as the nodal office under the LSGD to look into all matters related to UIDF projects to ensure better utilization of the funds. The Nodal Office must collect and vet the proposals and set up a committee to give sanctions. 10th SHPSC has also decided that regarding the State share proposals of AMRUT, the Mission Director AMRUT shall submit the proposals through the Principal Director LSGD.

2. As per the letter read as 3rd paper above, the Mission Director, AMRUT has requested to issue orders based on the decision of 10th SHPSC.

3. Government are pleased to designate the Principal Directorate of

LSGD as the Nodal Office, under the LSGD to look into all matters related to UIDF projects to ensure better utilization of the funds. The Nodal Office shall collect and vet the proposals and set up a committee to give sanctions. The Mission Director AMRUT shall submit the State share proposals of AMRUT, through the Principal Director LSGD.
