ORDER

As per paper read as 1 st above, the Government have authorized the Kudumbashree as the nodal implementing agency of the New Urban Poverty Alleviation Mission in the State and the Executive Director, Kudumbashree as the State Mission Director for the Scheme and also accorded sanction for the constitution of a High Powered Committee (HPC), District Level Committee (DLC), Executive Committee at ULB Level with the Executive Director, Kudumbashree and the District Mission Co ordinator, Kudumbashree as Convenor at the State and District level respectively, with representatives from various line departments, for the effective implementation of New Urban Poverty Alleviation Mission in the State of Kerala. As per paper read as 2nd above, Sanction was accorded for releasing an amount of Rs.4,38,00,000/- (Rupees Four Crore Thirty Eight Lakh Only) towards the release of Central Share received for the implementation of Pilot Project for Urban Poverty Alleviation focusing on livelihoods during 2024-25 under Deendayal Jan Aajeevika Yojana -Shehari (DJAYS) for the year 2024-25, channeling the allocated funds to

the SNA of DJAYS.

(2) The Ministry of Housing & Urban Affairs (MoHUA), as per letter read as 3rd paper above, has accorded sanction for the release of ₹ 5,00,00,000/- (Rupees Five crore only) to the State Government of Kerala as Central Assistance under Deendayal Jan Aajeevika Yojana — Shehari [D- JAY(S)] - Pilot Project for the financial year 2025-26, and requested to transfer the released amount to the Pilot Cities (Kochi & Thiruvananthapuram) for the smooth implementation of the Pilot Project.

- (3) As per the letter read as 4th paper above, the Executive Director, Kudumbashree has informed that the Ministry of Housing & Urban Affairs (MoHUA) has sanctioned an amount of ₹ 5,00,00,000/- for piloting DJAY-S in Thiruvananthapuram and Kochi Corporations and requested to release the allocated funds released under the pilot implementation of DJAY-S through the Directorate of Urban Affairs to the SNA account of DJAY(S). At present, there is no budget provision during the FY 2025 26 to receive the central funds released for the DJAY-S pilot project . As per paper read as 5th above ,Sanction has been accorded for an additional expenditure to the tune of Rs. 5,00,00,000/-(Rupees Five Crore rupees Only) under the H/A 2217-05-191-48 (60) Central Share, for the release of Central Share received for the implementation of Pilot Project for Urban Poverty Alleviation focusing on livelihoods during 2025-26 under Deendayal jan Aajeevika Yojana Shehari (DJAYS).
- (4) Government have examined the matter in detail and are pleased to release of an amount of Rs. 5,00,00,000/- (Rupees Five Crore rupees Only) towards the release of Central Share received for the implementation of Pilot Project for Urban Poverty Alleviation focusing on livelihoods under Deendayal Jan Aajeevika Yojana- Shehari (DJAYS) for the year 2025 26, channeling the allocated funds under the H/A 2217-05-191-48 (60) Central Share, to the SNA of (DJAYS) Account Number: 110232776974 in Canara Bank, Cosmopolitan Hospital Branch Trivandrum IFSC: CNRB0002499.
- (5) As the Director (URBAN) serves as the parent agency responsible for channeling the allocated funds to the SNA account of Deendayal Jan Aajeevika Yojana Shehari (DJAYS) to Kudumbashree, and an allotment shall be made in BAMS by the Director (Urban) to the Director (A&F), Kudumbashree, who functions as the Drawing and Disbursement Officer (DDO Code: 0101996001) of Kudumbashree.
- (6) The Executive Director, Kudumbashree shall take timely steps to transfer the released amount to the Pilot Cities as detailed above, for

smooth implementation of the Pilot Project, under Deendayal Jan Aajeevika Yojana - Shehari (DJAYS).
