As per paper read as 2 nd above, Government have accorded in principle sanction for the "Urban Rejuvenation and Beautification Scheme" as detailed in the Budget Speech 2023 - 24 for an amount of Rs 300 Crores and to implement the scheme in the three major cities Thiruvananthapuram, Kochi and Kozhikode availing KIIFB assistance of Rs 100 Crores and selected IMPACT Kerala Ltd (IKL) as Special Purpose Vehicle (SPV) for the works in Kozhikode Corporation, under the scheme.

- (2) As per paper read as Ist above ,Government have revised the existing limits of financial powers delegated to various Engineering Departments and the Superintending Engineer (SE) of the respective Corporations (Thiruvananthapuram & Kochi) have delegated powers of Rs. 2.5 Crore for Technical Sanction (TS). During the meeting convened by the Chief Principal Secretary (CPS) to Chief Minister to discuss State Budget 2023 24 announcement on "Urban Rejuvenation and City Beautification Scheme", it was decided to enhance powers to the TS Committee for issuing sanctions upto 15 Crore for this particular project.
- (3) Government have examined the matter in detail and are pleased to accord sanction to enhance the delegated powers of the Superintending Engineer (SE) of the Thiruvananthapuram & Kochi Municipal
