In the Annual Plan for the year 2025-26, under the head of account 2217-80-800-60 an amount of Rs.471.00 lakhs has been earmarked for establishing solid waste treatment plants (erstwhile solid waste management fund)

The objective of the scheme 'Development of integrated solid waste management projects', is to provide a viability gap fund for the development of integrated solid waste management projects, including waste-to-energy plants at identified locations in Public Private Partnership mode. The provision is earmarked to meet the State share of Viability Gap Fund for the Palakkad WtE Plant. An amount of ₹ 471.00 lakh is provided for this scheme in 2025-26.
