ORDER

The Ministry of Rural Development (MoRD), GoI, vide letter read as 2nd paper above, had sanctioned a total amount of ₹1,95,00,000/- (General- ₹1,71,70,000/-, SCP- ₹ 20,13,000/- and TSP- ₹ 3,17,000/-) as the 1st tranche of 1st installment of Mother Sanctioned Fund of Central share under SNA SPARSH for the year 2025-26 for the implementation of Mahila Kisan Sashaktikaran Pariyojana- Integrated Farming Cluster (MKSP-IFC). Being the implementation agency of MKSP in Kerala, the Executive Director, Kudumbashree, as per the letter read as 3rd paper above, has requested to release a total amount of ₹ 3,25,00,000/-, towards the aforesaid Central share along with its matching State share of ₹ 1,30,00,000 (General-₹ 1,14,46,667/- SCP- ₹ 13,42,000/- and TSP- ₹ 2,11,333/-).

2.Government have examined the matter and are pleased to accord sanction to release a total amount of ₹ 3,25,00,000/- (Rupees Three Crore and Twenty Five Lakh only) to the Principal Director, LSGD

towards the Central release and its matching State Share for the year 2025-26 for the implementation MKSP in the State from the current year's budget provision, as shown below, subject to the conditions stipulated in the Circular read as 1st paper above.
