ORDER

As per the proceedings read as 1st paper above, Shri.V.Shajimon, former Law Officer in State Election Commission, was engaged as Legal Consultant to the State Election Commission, on contract basis for a period of one year with effect from 01.10.2024 with the condition that his pay, terms and conditions will be fixed later.

Vide letter read as 2nd paper above, Secretary of State Election Commission requested to ratify the action of State Election Commission in having appointed Shri.V.Shajimon on contract basis as Legal Consultant to the State Election Commission for a period of one year w.e.f 01.10.2024 and to permit to extend his appointment till 31.3.2026 (i.e. up to the tenure of the present Hon'ble Commissioner

which is to expire on 30.03.2026) by fixing a pay equivalent to that of Category XII (₹57,525/-) in the annexure to G.O. (P)No.29/2021/Fin dated 11.02.2021.

In continuance, as per proceedings read as 3rd paper above, The State Election Commission extended the appointment of Shri.V.Shajimon, former Law Officer in State Election Commission, as Legal Consultant to the State Election Commission, on contract basis for a further period up to 31.03.2026.

Government have examined the matter in detail and are pleased to accord sanction to ratify the action of State Election Commission in having appointed Shri.V.Shajimon on contract basis as Legal Consultant to the State Election Commission for a period of one year w.e.f 01.10.2024 and also hereby permitted to extend his appointment till 31.03.2026 by fixing his contract wages at Rs. 50,000/- per month.
