Read 1 Scheme Guidelines for restructured and extended version of Pradhan Mantri Street Vendor's Atma Nirbhar Nidhi (PM SVANidhi) by Ministry of Housing & Urban Affairs (MoHUA)

### ORDER

As per paper read above, the Ministry of Housing & Urban Affairs, Government of India has introduced restructured and extended version of Pradhan Mantri Street Vendor's Atma Nirbhar Nidhi (PM SVANidhi) to broaden its impact by deepening financial inclusion, promoting digital adoption and ensuring socio - economic upliftment of vendors and their families. More regular and organized coordination is required among the stakeholders for speedy implementation of the scheme and delivering scheme deliverables without delay. As per Section 13 (b) of the scheme Guidelines as per paper read above, the Scheme shall have State Level Monitoring Committee under the chairmanship of Principal Secretary/Secretary of Urban Development/Municipal Administration, which shall meet at least every three months and also the Scheme shall have District Level Monitoring Committee headed by District Collector/CEOs Zila Parishad (as decided by the State/UT), which shall meet every month. Also the Scheme shall have a Monitoring Committee headed by the Municipal Commissioner/ Executive Officer (EO)/ CEO Cantonment Boards and supported by the Town Vending Committee, which shall meet every month.

(2) Government have examined the matter in detail. As per Section

13 (b) of the scheme Guidelines, Government are pleased to constitute State Level & District Level Monitoring Committees under the chairmanship of Additional Chief Secretary/Principal Secretary/Secretary, Local Self Government Department & District Collector (DC) respectively, with a composition outlined below as per PM SVANidhi Scheme Guidelines for the implementation plan of the restructured and extended form of the Pradhan Mantri Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Scheme. Sanction is also accorded to constitute ULB Level Monitoring Committee headed by the Secretary of the ULB concerned, with composition outlined/suited below, in compliance with PM SVANidhi Scheme Guidelines. State Level, District Level & ULB Level Monitoring Committees shall meet at least every three, one months each respectively as indicated below.
