ORDER

The XVth Finance Commission has recommended an amount of Rs.255 crore as Tied grant for Million Plus Urban Agglomerations for the year 2024-25.

2) The Director, FCD vide, letter read as 4th paper above, has conveyed the release of Undisbursed Grant of Solid Waste Management (SWM) Component of the Million Plus Challenge Fund to other eligible Non-Million Plus cities (NMPCs) as recommended by the 15th Finance Commission for the year 2024-25 amounting to ₹263.9386 crore. It has been requested to transfer the grant-in-aid directly to the Urban Development Department, the Nodal Department for ULBs.

3) Government, after having examined the matter in detail, are pleased to transfer an amount of **₹263,93,86,000/- (Rupees Two Sixty Three crore Ninety Three lakh Eighty Six thousand only)** as Undisbursed Grant of Solid Waste Management Component (SWM) in FY 2024-25 of the Million Plus Challenge Fund to other eligible Non-Million Plus cities (NMPCs) from the

Budget Provision 2026-27 under h/a '3604-00-200-85-06-35' in view of the Govt order read as 5th paper above.

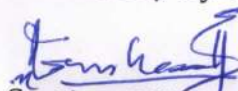
