ORDER

As per the letter read as 1st paper above, the Ministry of Housing and Urban Affairs has conveyed the release of an amount of Rs.20,00,00,000/- (Rupees Twenty Crore only as Central Share towards the implementation of projects of ULBs approved under AMRUT 2.0 for the FY 2026-27, under SLS KL-311 (33.33 % Central Share).

2. As per the letter read as 2nd paper above, the Mission Director, AMRUT has reported that the total budget outlay for the FY 2026–2027 under the Heads of Account for the release of fund to ULBs, in accordance with the funding pattern mentioned above, is as follows:
