### ORDER

The Ministry of Rural Development, Government of India had, vide letter read as 2nd paper above, issued Mother Sanction for a total amount of ₹120,25,38,000/- (General-₹105,85,94,000/-, SCP- ₹12,42,22,000/- and TSP-₹1,97,22,000/-) as the first installment of the Central share for the implementation of NRLM for the year 2026-27. Accordingly, the Executive Director, Kudumbashree, the SNA of the scheme, has as per letter read as 3rd paper above, informed that the total matching State share corresponding to the mother sanction is ₹80,16,92,000/-(General - ₹70,57,29,333/-, SCP-₹8,28,14,667/- and TSP - ₹1,31,48,000/-). As the budget provision in the State budget 2026-27 is insufficient to release the entire amount (₹200,42,30,000/-), the Executive Director has requested to release the available amount towards the first installment of Mother Sanction, at the earliest.

2.Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹69,40,00,000/- (Sixty Nine Crore and Forty Lakh Only) towards the partial release of the Central share and its corresponding State share for the Financial Year 2026-27 for the implementation of NRLM in the State, from the current Year's budget provision, as shown below;
