ORDER

Shri. Pradeesh Kumar V. K., while working as Assistant Executive Engineer in Pattambi Block Panchayat, was transferred to Kozhikode Corporation vide order read as 1st paper above. Aggrieved by this transfer, he filed OA No.392/2026 before the Hon'ble Kerala Administrative Tribunal with a prayer to retain him in his present station.

As per the order read as 1st paper above, as subsequently corrected vide order read as 4th paper above, Assistant Executive Engineer Smt. Surabhi C. S. (PEN: 612232), serving in Kozhikode Corporation, and

Assistant Executive Engineer Shri. Pradeesh Kumar V. K. (PEN: 439419), serving in Pattambi Block Panchayat, Palakkad District, were transferred and appointed on mutual transfer basis.

The Hon'ble KAT vide order read as 3rd paper above, disposed of the OA with a direction to the 1st respondent (Principal Secretary, LSGD) to consider and pass orders on Annexure A3 representation, within a period of two months. The Hon'ble Tribunal also directed that the transfer order shall not be implemented in respect of the applicant until a decision is taken on Annexure A3 representation.

The Annexure A3 representation is the request of the applicant to retain him in Pattambi Block Panchayat, stating that he has been working in the present station for less than eight months only. He has also stated that he is suffering from diabetic retinopathy and diabetic neuropathy and that the transfer would cause severe personal hardship.

Government have examined the matter in detail and find that the request of the applicant in Annexure A3 to retain him in Pattambi Block Panchayat deserves consideration and hence is allowed. Consequently, the transfer order read as 1st paper above, as corrected vide order read as 4th paper above, stands cancelled to the extent it relates to the applicant and Smt. Surabhi C. S. Accordingly, Shri. Pradeesh Kumar V. K. is retained in Pattambi Block Panchayat and Smt. Surabhi C. S. is retained in Kozhikode Corporation.

The order of the Hon'ble KAT in OA No.392/2026, read as 3rd paper above, is complied with accordingly.
