ORDER

Shri. Biju V. G, while working as an Assistant Engineer in Sulthan Bathery Municipality, was transferred to Kaniambatta Grama Panchayat vide Annexure A1. Grievied by this transfer, he filed OA(EKM) No. 316/2026 before the Hon'ble Kerala Administrative Tribunal, Ernakulam.

2) The Hon'ble Kerala Administrative Tribunal, Ernakulam, vide order read as 3rd para above, disposed of the OA with a direction to the 1st respondent (Principal Secretary, LSGD) to consider and pass order on Annexure A3 within a period of one month from the date of receipt of a copy of the order. The Hon'ble Tribunal has also made it clear that, till such orders are issued, the transfer of the applicant and the 5th respondent shall remain in abeyance.

3)The Annexure A3 representation addressed to the 2nd respondent, is the request of the applicant to set aside the transfer order and to retain him in Sulthan Bathery Municipality, stating that he is a person with locomotor disability and that the transfer was effected prior to general transfer without following normal process causing mental hardship and affecting official work. The applicant has contended that he joined the present station on 19.07.2023 and was transferred before completing the normal tenure of 3 years.

4)As directed by the Hon'ble Tribunal, Government have examined the matter in detail and find that the request of the applicant in Annexure A3 to retain him in Sulthan Bathery Municipality deserves consideration and hence is allowed. Consequently, Annexure A1 transfer order stands cancelled to the extent it relates to the applicant and the 5th respondent.

5)The order of the Hon'ble Kerala Administrative Tribunal, Ernakulam in OA(EKM) No. 316/2026 read as 3rd paper above is complied with accordingly.
