### ORDER

Government are pleased to accord sanction to release an amount of ₹89,80,232/- (Rupees Eighty Nine Lakh Eighty Thousand Two Hundred and Thirty Two only) being the Second & Part Bill reimbursement claim against the expenditure incurred by the Panchayat for the NABARD RIDF Tranche XXIX project, “She Work Space at Kodakara Block Panchayath in Thrissur,” to the Block Panchayat from the current year's budget provision under the H/A 2515-00-197-50-(01)35 (PV), as shown in the table below, considering the proposal read as 3rd paper above. An amount of ₹28,09,743/- has been adjusted towards MA from the RIDF share of the present RC.
