ORDER

Out of the total amount ₹200,42,30,000 /- to be released towards the amount Mother Sanctioned by the Ministry of Rural Development (MoRD), as per letter read as 2nd paper above, and its matching State share, an amount of ₹69,40,00,000/- had been released as per the Government order read as 4th paper above. Now, as per the Government order read as 5th paper above, an amount of ₹104,10,00,000/- has been reappropriated to the respective heads of account.
