As per letter read above, the Project Director, KSWMP requested to transfer credit an amount of Rs. 35,50,00,000/- (Rupees Thirty Five Crore Fifty Lakhs Only) to the PSTSB Account No. 799012700002536 of KSWMP under Component 1 and 3 of the Project, for meeting the expenditure requirements up to June 2026.
