### ORDER

The Ministry of Rural Development (MoRD), GoI, as per letter read as 2nd paper above, issued Mother Sanction to release an amount of ₹184.2734 crore as the 1st Installment of the 1st Tranche of Central Assistance towards the Material component under SNA SPARSH for the year 2026-27 for the implementation of MGNREGA in the State. Accordingly, out of the total amount of ₹245,69,78,667/- to be released, along with the corresponding state share, an available amount of ₹229,34,00,000/- had been released as per Government order read as 4th paper above. Now as per Government order read as 5th paper above, an additional expenditure in tune of ₹245,69,79,000/- has been authorized under the respective head of account.

2. In this circumstance Government are pleased to accord sanction to release the balance amount of ₹16,35,78,667/- (Rupees Sixteen Crore

Thirty Five Lakh Seventy Eight Thousand Six Hundred and Sixty Seven Only) under the h/a 4515-00-103-97-02 (P-V) towards the Material component of the Central share and its corresponding State share for the Financial Year 2026-27 for the implementation of MGNREGS in the State, from the current year's budget provision.

3. The guidelines, conditions and procedures stipulated in the Circular read as 1<sup>st</sup> paper above and the Sanction order read as 2<sup>nd</sup> paper above should strictly be followed and complied with.
