### ORDER

The Ministry of Rural Development, Government of India, as per letter read as 2nd paper above, issued Mother Sanction for an amount of ₹ 514,07,33,000/- [SC: ₹90,90,65,000/-, ST: ₹34,76,91,000/- and Others: ₹388,39,77,000/-] as the First Installment of the Central Assistance towards unskilled wage component under DBT SPARSH for the implementation of Viksit Bharat - Guarantee for Rozgar and Aajeevika Mission (Gramin) Scheme for the financial year 2026-27. Accordingly, the Mission Director, VB-G RAM G, as per letter read as 3rd paper above, has requested to release a total amount of ₹856,78,88,333/- as the First Installment of the Central Assistance towards unskilled wage component under DBT SPARSH for the implementation of Viksit Bharat - Guarantee for Rozgar and Aajeevika Mission (Gramin) Scheme for the financial year 2026-27, including the corresponding State Share of ₹ 342,71,55,333/- [SC: ₹ 60,60,43,333/- , ST: ₹ 23,17,94,000/- and

Others: ₹ 258,93,18,000/-].

2. Government have examined the matter in detail. As per Government order read as 4th and 5th paper above, separate budget heads for the SC, ST, and Other wage components have been created and required amounts have been allocated in respective head of accounts.

3. In this circumstance, Government are pleased to accord sanction for the release of ₹ 856,78,88,333/- (Rupees Eight Hundred Fifty Six Crore Seventy Eight Lakh Eighty Eight Thousand Three Hundred and Thirty Three only) as the First Installment of the Central Assistance towards unskilled wage component along with its corresponding state share, under DBT SPARSH, for the implementation of Viksit Bharat - Guarantee for Rozgar and Aajeevika Mission (Gramin) Scheme for the financial year 2026-27, from the current year's budget provision, as detailed below.
