ORDER

As per the letter read as 1st paper above, the Ministry of Housing and Urban Affairs has conveyed the release of an amount of Rs.30,00,00,000/- (Rupees Thirty Crore Only) as Central Share towards the implementation of projects of ULBs approved under AMRUT 2.0, for the FY 2026-27, under SLS KL-312 (50 % Central Share). For such ULBs (Municipalities with population <1 lakh - 84 ULBs), the funding pattern is as follows

Central share-50%

State share - 50% (including ULB Share)

2. The total budget outlay for the FY 2026–2027 under the Heads of Account for the release of fund to ULBs, in accordance with the funding pattern mentioned above, is as follows:

3. Under SNA SPARSH, both the Central share and State share have to be released from the Head of Account corresponding to State Share. As per the letter read as 2nd paper above the Mission Director AMRUT has requested to accord sanction for the release of ₹60,00,00,000/- (Rupees Sixty Crore only), comprising the Central Share along with the corresponding State Share, to the State Mission Directorate under AMRUT 2.0 from the Head of Account as detailed below;

4. The Mission Director, AMRUT has also requested to allocate the amount of Rs.60,00,00,000/- into the SCO Code: 67DL01(Mission Director, AMRUT the SCO of Major Head-2217) for Centrally Sponsored Schemes with the Sub Treasury, Vellayambalam.

5. Government have examined the matter in detail. Out of the total budget provision of ₹112,51,97,000/- (Rupees One Hundred Twelve Crore Fifty-One Lakh Ninety-Seven Thousand only) available under the State Share Head of Account 2217-05-192-48 (28), an amount of ₹60,00,00,000/- has already been released based on the previous mother sanction received from Government of India. Thus, the balance amount available for further release under the said Head of Account is ₹52,51,97,000/- (Rupees Fifty-Two Crore Fifty-One Lakh Ninety-Seven Thousand only).

6. In these circumstances, Government are pleased to accord sanction for the release and allocation of an amount of **₹52,51,97,000/- (Rupees Fifty-**

Two Crore Fifty-One Lakh Ninety-Seven Thousand Only) (Central Share- ₹26,25,98,500/- and State Share ₹26,25,98,500/-) into the SCO Code: 67DL01 (Mission Director, AMRUT the SCO of Major Head-2217) for Centrally Sponsored Schemes with the Sub Treasury, Vellayambalam, towards the implementation of projects of ULBs approved under AMRUT 2.0, from the balance provisions available under the budget head for state share, for the FY 2026-2027, as detailed below;
