ORDER

As per the letter read as 1st paper above, Ministry of Housing & Urban Affairs has conveyed issuance of Mother Sanction of ₹7,77,84,000/- (Rupees Seven Crore Seventy Seven Lakh Eighty Four Thousand Only) as further payment to the Govt. of Kerala towards AMRUT MITRA an initiative under AMRUT 2.0 for implementation of projects against the total work order cost of 3,111.36 Lakh, as detailed below;

4. The existing budget allocation for the above Heads of Account is Rs.1,00,000/- each. As per G.O read as 3rd paper above, additional expenditure to the tune of Rs.7,75,85,000/-(Rupees Seven Crore, Seventy Five Lakh Eighty Five Thousand Only) has been authorized under the respective head(s) of account for utilization of the Central Assistance received, in accordance with the SNA-SPARSH fund flow mechanism for the Administrative and Other Expenses (A&OE) component under AMRUT 2.0

Government have examined the mater and are pleased to accord sanction for the release of an amount of Rs.7,77,84,000/- (Rupees Seven Crore Seventy Seven Lakhs Eighty Four Thousand only) and to allocate the amount to the Mission Director AMRUT (DDO CODE: 010467D053) for utilization of the Central Assistance received, in accordance with the SNA-SPARSH fund flow mechanism for the Administrative and Other Expenses (A&OE) component under AMRUT 2.0, as detailed above.
