ORDER

As per Government order read as 2nd paper above, sanction had been accorded to release an amount of ₹4,65,00,000/- towards the First Mother sanction and its matching State share for the Financial Year 2026-27 for the implementation of projects under WDC-PMKSY 2.0. The Department of Land Resources (MoRD), GoI, vide letter read as 3rd paper above, issued Second Mother Sanction for a total amount of ₹2.78 crore towards Q1+Q2 of the Financial year 2026-27 for the implementation of projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0) in the State. Being the implementing agency of the state, the Principal Director, LSGD as per the letter read as 4th paper above, has informed that the corresponding State share for the Second Mother sanction is ₹1.85 crore and requested to release a total amount of ₹.4.63 Crore from the head of account 2515-00-102-37(02).

2.Government have examined the matter in detail. As per Government

order read as 2nd paper above, sanction had already been accorded to release an amount of ₹4,65,00,000/- in accordance with the First Mother sanction for the Financial Year 2026-27 and therefore the available balance in the head of account 2515-00-102-37(02) is insufficient to release the entire amount corresponding to the Second Mother sanction.

3. In this circumstance Government are pleased to accord sanction to release an available amount of ₹2,35,00,000/- (Rupees Two Crore and Thirty Five Lakh only) towards the Second Mother sanction and its matching State share for the Financial Year 2026-27 for the implementation of projects under Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0), from the current Year's budget provision under the Head of account 2515-00-102-37 (02).

4. The guidelines and procedures stipulated in the Circular read as 1st paper above and the Sanction order read as 3rd paper above shall strictly be followed and complied with.

5. The remaining amount will be released shortly. The Principal Director, LSGD shall furnish the Re-appropriation / Additional Authorization proposal for the releasing of the balance amount.
