ORDER

As per Government order read as 1st paper above, sanction was accorded for the release of Rs.18,76,66,000/- (Rupees Eighteen Crore Seventy Six Lakh Sixty Six Thousand Only) as central share and matching state share towards various components except Used Water Management (UWM) under Swachh Bharat Mission (Urban) 2.0, the Centrally Sponsored Scheme implemented by Suchitwa Mission.

(2) As per letter read as second above, the Executive Director, Suchitwa Mission has requested for the release of Rs 88.33 Lakh (Rs 53 lakh central share & Rs 35.33 Lakh state share) for the component - 'Used Water Management' under SBM (U) 2.0. The Executive Director has also requested that re-appropriation of amounts be sanctioned such that the higher demand in Municipality head can be met.

(3) As per the Government Order read as 3rd paper above, sanction was accorded for the re-appropriation of Rs 88,33,000/- (Rupees Eighty

Eight Lakh Thirty Three Thousand Only) under the Major Head of Account "2217 – Urban Development" for the implementation of SBM (Urban) 2.0 – Used Water Management Component, by reallocating funds for the utilisation of the Central Assistance and the corresponding State Share from the single budget line of the State Share, in accordance with the fund flow mechanism prescribed under the newly introduced SNA-SPARSH system.

(4) Government have examined the matter in detail and are pleased to release an amount of Rs 88,33,000/- (Rupees Eighty Eight Lakh Thirty Three Thousand Only) as Central share and matching State share towards Used Water Management Component of Swachh Bharat Mission (Urban) 2.0 for the year 2026-27.

(5) Sanction is also accorded to the CCO of the Head of account - Principal Director, LSGD to allocate the amount to SCO - the Executive Director, Suchitwa Mission to distribute the fund to Local Self Government Institutions as per the guidelines of Swachh Bharat Mission (Urban) 2.0 through SNA SPARSH Module.
