ORDER

As per the Government Order read as 1st paper above, an amount of Rs.16,66,66,000/- (Rupees sixteen crore sixty six lakh sixty six thousand only) was sanctioned as central share and matching state share for the implementation of projects under Swachh Bharat Mission (Grameen) for the year 2026-27.

(2) Vide letter read as second paper above, the Executive Director, Suchitwa Mission informed that additional mother sanction of an amount of Rs. 20 Crore has been sanctioned to the State of Kerala, and the corresponding state share required is Rs 13.34 Crore, as tabulated below:
