ORDER

As per G.O read as 2nd paper above, Administrative Sanction was accorded for the project “Restoration of Natural Water Resources by Protecting Natural Drains - Construction of Side Wall at Kotteppadam (Division 17) - KER2023-24000015” of Thrissur Municipal Corporation under UIDF Tranche-I (with a total project cost of Rs. 5.17 Cr and a loan amount of Rs 4.65 Cr form National Housing Bank)

2. As per the letter 3rd paper above, the Principal Director, Local Self Government Department has forwarded proposal and documents submitted by the Secretary, Thrissur Municipal Corporation, for releasing ₹1,17,85,761/- towards the First Part Bill amount of Reach 1 and ₹1,07,08,355/- towards the First Part Bill amount of Reach 2 under the above mentioned project.

3. As per G.O read as 4th paper above, additional expenditure to the tune of Rs.1,86,00,000/- (Rupees One Crore Eighty Six Lakh Only) under Head of Account 6217-60-800-86- Urban Infrastructure Development Fund ₹1.86 crore (Rupees One Crore Eighty-Six Lakh only) to release and disburse the RC amount in respect of the 1st tranche of UIDF scheme 'Restoration of natural water resource by protecting natural drains - side

wall construction of Kotteppadam (Division 17)'.

4. As per G.O read as 5th paper above, Principal Director, LSGD has been declared as Chief Controlling Officer (CCO) of the said Head of Account.

5. Government have examined the matter and are pleased to release an amount of ₹1.86 crore (Rupees One Crore Eighty-Six Lakh only) (as first installment of loan - 40 % of approved loan amount of Rs 4.65 Cr) from the Head of Account "6217-60-800-86 –Urban Infrastructure Development Fund (UIDF) Scheme with the Loan Assistance of the National Housing Bank (NHB) (Non Plan -Voted) to Thrissur Municipal Corporation for the UIDF Tranche-I project, "Restoration of Natural Water Resources by Protecting Natural Drains – Construction of Side Wall at Kotteppadam (Division 17)", subject to the condition that the principal and interest payable on the National Housing Bank loan shall be deducted from the Development Fund of the Thrissur Municipal Corporation, as stipulated in G.O read as 1st paper above.

6. The Principal Director, Local Self Government Department, being the Chief Controlling Officer of the Head of Account, shall take timely action for allocation and disbursement of the fund to the Thrissur Municipal Corporation and regularization of the above additional expenditure through re appropriation of savings within the Grant/Supplementary Demands for Grants before the close of the current financial year.
