ORDER

Smt. A.K. Saraswathi and others, retired Municipal employees and service pensioners, filed OA No.1134/2025 before the Hon'ble Kerala Administrative Tribunal, against the non-disbursal of pension revision arrears and other pension arrear. The applicants sought directions for the release of sufficient funds from the Central Pension Fund for disbursement of the pending pension arrears and other eligible pensionary benefits.

2.The Hon'ble Kerala Administrative Tribunal, vide judgment read as 1st paper above, disposed of the Original Application directing the Government to consider the grievances of the applicants after affording an opportunity of hearing to the applicants and respondents 2 and 3 and to take appropriate steps for the release of funds to ensure payment of pension and other eligible benefits to the applicants.

3.In compliance with the directions of the Hon'ble Tribunal, the applicants were heard online, the Superintendent, Vaikom Municipality (2nd respondent) and the Finance Officer, Office of the Principal Director, Local Self Government Department (3rd respondent), on 23.10.2025. During the hearing, the Finance Officer, Office of the Principal Director, Local Self Government Department, reported that it is decided to allot the required amount to Vaikom Municipality from the Central Pension Fund.

Accordingly, the Principal Director, Local Self Government Department, allotted an amount of ₹8,45,112/- (Rupees Eight Lakh Forty-five Thousand One Hundred and Twelve only) to the Secretary, Vaikom Municipality for disbursement of the pension arrears due to the applicants.

4.The Secretary, Vaikom Municipality vide letter read as 3rd paper above has reported that the pension arrears due to to the applicants have been disbursed as follows.
