ORDER

As per the Government Order read as 1st paper above Administrative Sanction was accorded for Rs.3,79,17,241/- (Rupees Three Crores Seventy Nine lakh Seventeen Thousand Two hundred and forty one only) for the construction of a LIFE Apartment (Housing Complex) comprising 24 units, in a land donated by Shri. Shameer Pookkuzhi in Nellikuzhy, Grama Panchayat. An agreement was executed between the Secretary, Nellikuzhy, Grama Panchayat and LIFE Mission

on 07.10.2023 as per which an amount of Rs.379.17 Lakh is to be given to Nellikuzhy, Grama Panchayat by LIFE Mission in five installments according to the progress of the work. The first installment of Rs.75,39,962/- was sanctioned as per orders read as 2nd and 3rd paper above, and the second and third installment of Rs.80,00,000/- was sanctioned as per order read as 4th and 5th paper above.

2.The amount of ₹80,00,000/- (Rupees Eighty Lakhs only) allotted as the 2nd installment to the Secretary, Nellikuzhy Grama Panchayat, as per the order read as 4th paper above, could not be utilised/credited to M/s. Uralungal Labour Contract Co-operative Society due to Treasury restrictions and was consequently resumed at the end of the financial year. The Chief Executive Officer, LIFE Mission, as per the letter read as 6th paper above requested to re-allot the resumed amount of ₹80,00,000/- (Rupees Eighty Lakh only) from the Head of Account 4515-00-102-49-PV to the PSTSB A/c No. 799012700002772 of the Secretary, Nellikuzhy Grama Panchayat, at Sub Treasury, Kothamangalam.

3. Government have examined the matter in detail, and are pleased to release the amount of Rs. Rs. 80,00,000/- (Rupees Eighty Lakhs only) from the H/a 4515-00-102-49-PV to the PSTSB A/c No. 799012700002772 of the Secretary, Nellikuzhy Grama Panchayat at Sub Treasury, Kothamangalam as reallocation of the second installment towards the construction of LIFE Apartment in Nellikuzhy Grama Panchayath .
