ORDER

The Ministry of Rural Development, Government of India, as per letter read as 2nd paper above, issued Mother Sanction to release an amount of ₹342,71,56,000/- as the First Installment of the Central Assistance towards Material component and vide letter read as 3rd above issued Mother Sanction to release an amount of ₹68,54,31,000/- as the First Installment of the Central Assistance towards Admin component under SNA SPARSH for the implementation of the VB-G RAM G Scheme for the financial year 2026-27. The Mission Director,VB-G RAM G, has requested to release the fund along with matching state share. However, as the sufficient required for releasing the amount as per the Mother Sanction, namely ₹228,47,70,667/- under the Material Component and ₹45,69,54,000/- under the Administrative Component,

were not available under the respective State Share heads Government order read as 4th above accorded sanction for the partial release of ₹29,85,00,000/- (Rupees Twenty Nine Crore Eighty Five Lakh only) from the Head of Account 2505-02-101-87(04) towards the Material component and ₹11,71,00,000/- (Rupees Eleven Crore Seventy One Lakh only) from the Head of Account 2505-02-101-87(06) towards the Admin component through DBT SPARSH for the implementation of Viksit Bharat - Guarantee for Rozgar and Aajeevika Mission (Gramin) Scheme for the financial year 2026-27, from the budget provision for the current Financial Year.

(2) As the Heads of Account included in the Revised Budget Estimates for the financial year 2026-27 for the Material Component of the VB-G RAM G Scheme, namely 2505-02-101-87(03)-CS and 2505-02-101-87(04)-SS, fall under the Revenue Section, whereas the Material Component of the erstwhile MGNREGS was classified under the Capital Section, vide Government order read as 5th above the Material Component of the VB-GRAM G Scheme is shifted to to the Capital Section and sanctioned the following new Heads of Account.

(3) As per Government order read as 6th above authorised additional expenditure to the tune of Rs.581,52,12,000/- (Rupees Five Hundred Eighty One Crore Fifty Two Lakh Twelve Thousand Only) comprising ₹4,96,56,27,000/- for the Material Component under head of account 4515-00-103-94-(02), and ₹84,95,85,000/- for the Administrative Component under head of account 2505-02-101-87(06), to release funds for the utilization of the Central Assistance as per the Mother Sanction and the corresponding State Share for implementation of the of the VB-GRAM G Scheme -Material and Admin component. The re-appropriation of ₹17,57,00,000/- pertaining to the Administrative Component from the Central Share head of account 2505-02-101-87(05) to the State Share head of account 2505-02-101-

87(06) was also sanctioned vide Government order read as 7th above.
