ORDER

As per Government order read as 2nd paper above, sanction had been accorded to release an amount of ₹4,65,00,000/- towards the First Mother sanction and its matching State share for the Financial Year 2026-27 for the implementation of projects under WDC-PMKSY 2.0. Also as per Government order read as 4th paper above, sanction had been accorded for the partial release of an amount of ₹2,35,00,000/- for the Financial Year 2026-27, since the available balance in the corresponding head of account was insufficient to release the entire amount towards the Second Mother sanction, issued vide letter read as 3rd paper above. Therefore the Principal Director, LSGD, as per the letter read as 5th paper above, has requested to release the balance amount due to the Second Mother sanction, after re- appropriation in

respective head of account in order to facilitate timely fund release to meet the present operational requirements of WDC PMKSY 2.0.

2. Government have examined the matter in detail. As per Government order read as 6th paper above, sufficient amount has been re-appropriated to the State Head of Account for the release of the balance amount due to the Second Mother sanction. In this circumstance Government are pleased to accord sanction to release the balance amount of ₹2,28,00,000/- (Rupees Two Crore Twenty-Eight Lakh only), towards the Second Mother sanction and its matching State share for the Financial Year 2026-27, from the current Year's budget provision under the Head of account 2515-00-102-37 (02), for the implementation of projects under WDC-PMKSY 2.0.

3. The guidelines and procedures stipulated in the Circular read as 1st paper above and the Sanction order read as 3rd paper above shall strictly be followed and complied with.
