NOTIFICATION

G.O. (P) No. 171/2013/LSGD. *Dated, Thiruvananthapuram, 10th May, 2013.*

S. R. O. No. 408/2013. - WHEREAS, the Government of Kerala is of the opinion that the operational construction and land development works pertaining to Kochi Metro Rail Project and the Mono Rail Projects at Thiruvananthapuram and Kozhikode is a service whose operation, maintenance, development and execution is essential to the life of the community ;

NOW, THEREFORE, in exercise of the powers conferred under clause (h) of Rule 9 of the Kerala Municipality Building Rules, 1999 and clause (i) of Rule 9 of the Kerala Panchayath Building Rules, 2011, the Government of Kerala hereby declare that the works pertaining to Kochi Metro Rail Project and the Monorail Projects at Thiruvananthapuram and Kozhikode as services for the above purpose.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kochi Metro Rail Project at Kochi and the Mono Rail Projects at Thiruvananthapuram and Kozhikode for which approval sanction was accorded respectively by Government of India vide letter No. K-14011/37/2005-MRTS-IV dated 12th July, 2012 and by Government of Kerala vide G. O. (Ms.) No. 72/2012/PWD dated 9-10-2012, envisage improvement of citizens' mobility by encouraging greater use of public transport through the development of mass repaid transport systems. They being top prioritized projects, the Government intends to complete the same in a time bound manner. Considering the importance of these projects, the Government therefore desires to declare all operational constructions related to the Kochi Metro Rail Project at Kochi and the Mono Rail Projects at Thiruvananthapuram and Kozhikode as a service whose operation, maintenance, development and execution is essential to the life of the community under clause (h) of rule 9 of the Kerala Municipality Building Rules, 1999 and clause (i) of rule 9 of the Kerala Panchayath Building Rules, 2011.

The notification is intended to achieve the above object.
