In exercise of the powers conferred under sub- section (3) of section 46 of the Real Estate (Regulation and Development) Act, 2016 (Central Act 16 of 2016), the Government of Kerala hereby appoint the Selection Committee for the purpose of selection of Judicial Member and Technical or Administrative Member of the Kerala Real Estate Appellate Tribunal with the following Members, namely:-



1. Hon'ble Mr. Justice C. K. Abdul Rehim
(Nominee of the Chief Justice of the High Court of Kerala)
2. Secretary to Government, Department of Housing
3. Secretary to Government, Law Department (Convenor)

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-section (1) of section 43 of the Real Estate (Regulation and Development) Act, 2016 (Central Act 16 of 2016), the appropriate Government shall, within a period of one year from the date of coming into force of the Act, by notification, establish an Appellate Tribunal to be known as the Real Estate Appellate Tribunal. Section 45 of the said Act provides that the Appellate Tribunal shall consist of a Chairperson and not less than two whole time members of which one shall be a Judicial Member and other shall be a Technical or Administrative Member, to be appointed by the appropriate Government. As per sub-section (3) of section 46 of the said Act, the Judicial Members and Technical or Administrative Members of the Appellate Tribunal shall be appointed by the appropriate Government on the recommendations of a Selection Committee consisting of the Chief Justice of the High Court or his nominee, the Secretary of the Department handling Housing and the Law Secretary and in such manner as may be prescribed.

Accordingly, the Government have decided to appoint a Selection Committee for the purpose of recommending the Government, for the appointment of the Judicial Member and Technical or Administrative Member of the proposed Real Estate Appellate Tribunal.

The notification is intended to achieve the above object.
