WHEREAS, nine members of the Thengara Grama Panchayat had given notice of no-confidence motion against Smt. A. Saleena, President, Thengara Grama Panchayat on 7th September, 2019;



AND WHEREAS, a meeting of the said Grama Panchayat was held on 27th September, 2019 in the said Grama Panchayat Office under the Presidentship of the Secretary, Mannarkkad Block Panchayat to consider the said no-confidence motion;

AND WHEREAS, in the said meeting, out of the sanctioned strength of seventeen members, nine members have voted in favour of the no-confidence motion and the Secretary, Mannarkkad Block Panchayat has declared the no-confidence motion against Smt. A. Saleena as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the President of the said Grama Panchayat has come to an end and the Secretary, Mannarkkad Block Panchayat has reported the occurrence of the vacancy in the office of the President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Smt. A. Saleena has ceased to hold her office as President of the Thengara Grama Panchayat with effect from 27th September, 2019.
