WHEREAS, twenty-six members of the Kannur Municipal Corporation Council had given notice of no-confidence motion against Kumari E. P. Latha, Mayor of the Kannur Municipal Corporation on 5th day of August, 2019;

AND WHEREAS, a meeting of the said Municipal Corporation Council was held on 17th day of August, 2019 in the said Municipal Corporation Council Hall under the presidentship of the District Collector, Kannur to consider the said no-confidence motion;



AND WHEREAS, in the said meeting, out of the sanctioned strength of fifty-five members, twenty-eight members have voted in favour of the no-confidence motion and the District Collector, Kannur has declared the no-confidence motion against Kumari E. P. Latha as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the Mayor of the said Municipal Corporation has come to an end and the District Collector, Kannur has reported the occurrence of the vacancy in the office of the Mayor of the said Municipal Corporation to the Government and to the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Municipal Corporation;

Now, THEREFORE, in exercise of the powers conferred by sub-section (11) of section 19 of the Kerala Municipality Act, 1994 (20 of 1994), the Government of Kerala hereby notify that Kumari E. P. Latha has ceased to hold her office as Mayor of the Kannur Municipal Corporation with effect from 17th day of August, 2019.

Explanatory Note
