It is hereby notified that the Master Plan for Kottayam Town, in respect of the Joint Planning Area consisting of the whole of Kottayam Municipal Area, Vijayapuram Grama Panchayath Area and Panachikkadu Grama Panchayath Area with boundaries as described below; prepared by the Joint Town Planning Committee of Kottayam has been sanctioned by Government as per section 36(8) of the Kerala Town and Country Planning Act, 2016 (Act 9 of 2016) vide Government Order G.O.(Ms)No.80/2020/LSGD dtd 14/05/2020.

North: Ettumanoor Municipality, Athirampuzha Grama Panchayath, Arpookara Grama Panchayath

East : Manarcadu Grama Panchayath, Ayarakunnam Grama Panchayath, Puthupally Grama Panchayath and Vakathanam Grama Panchayath

South: Kurichy Grama Panchayath and Alapuzha district

West: Thiruvarpu Grama Panchayath, Aimanam Grama Panchayath, Arpookara Grama Panchayath and Alapuzha District.

The Joint Planning Committee of Kottayam shall publish the Master Plan as provided under sub-section 10 of section 36 of the Kerala Town and Country Planning Act, 2016.

No person shall use or cause to use any land or carry out development in any land, or change the use of land otherwise than in conformity with this Plan.

A digital copy of the proposed Land Use Map will also be published in the website of the Kottayam Municipality, Vijayapuram Grama Panchayath and Panachikkadu Grama Panchayath.
