As per Section 27 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005, Government of India have issued detailed instructions to the State Government to establish the Office of the Ombudsman for redressal of Grievances and disposal of complaints relating to implementation of the MGNREGS.

The rank list prepared by the Selection Committee, constituted vide G.O.(Rt)No.185/2021/LSGD



dated 22.01.2021 for preparing and recommending to Government a ranked panel of persons found suitable for appointment as Ombudsman for MGNREGS in accordance with the instruction issued by Government of India, was notified vide Notification No. DD2-344/2021/LSGD dated 11.03.2022 for public scrutiny.

After considering the objections received within the prescribed time limit, the Committee has recommended the rank list of persons for consideration for appointment as Ombudsman under MGNREGS in the districts of Kannur, Palakkad, Wayanad & Kasargod. Government have approved the rank list given as annexure to this notification, as per the recommendation of the Committee. The rank list will come into force with effect from the date of this notification and will be valid for three years.
